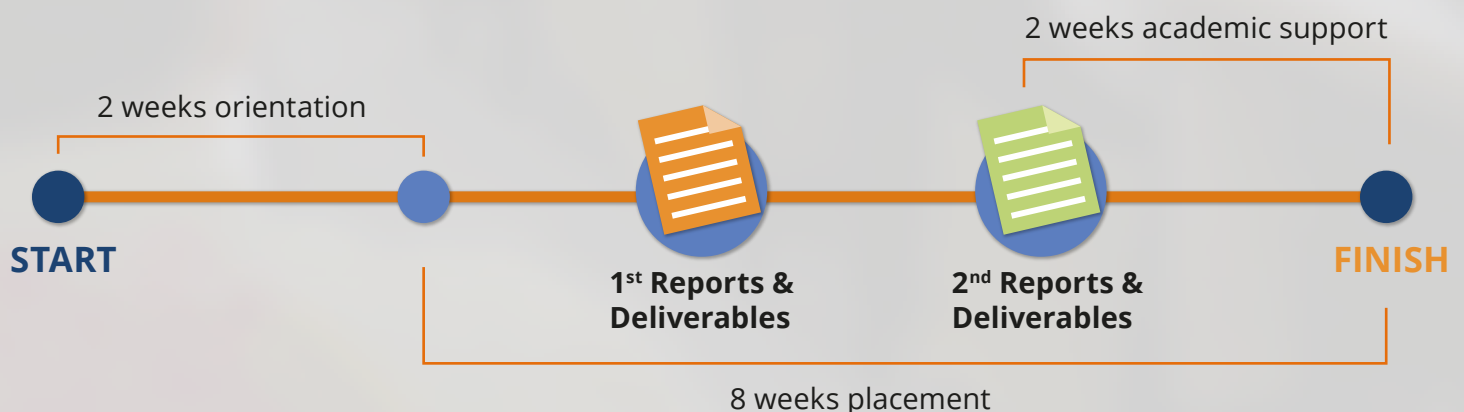

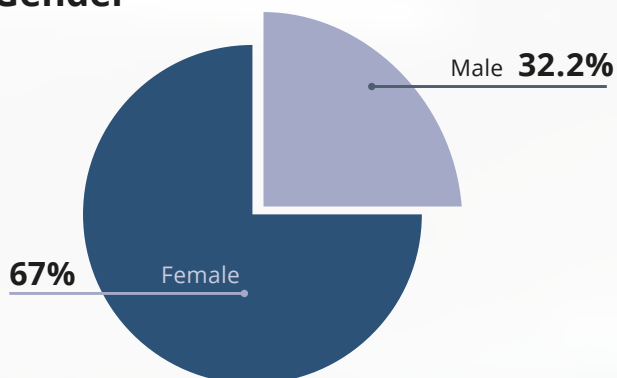
THE APPRENTICE'S PATH

The executive internship program commences **quarterly** and the internship period will last for a minimum of **two and a half (2.5) months**.

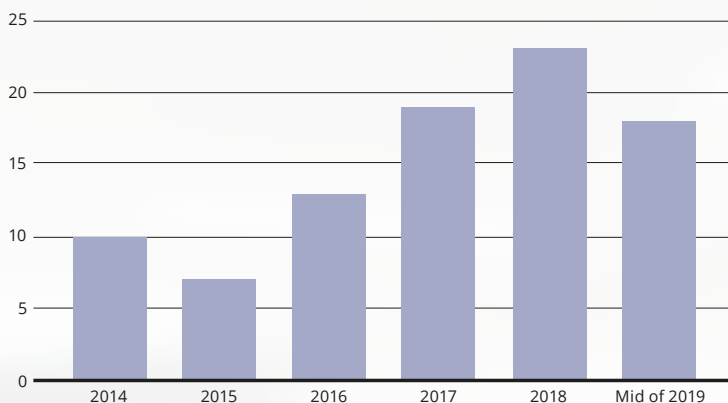


INTERNSHIP AT A GLANCE

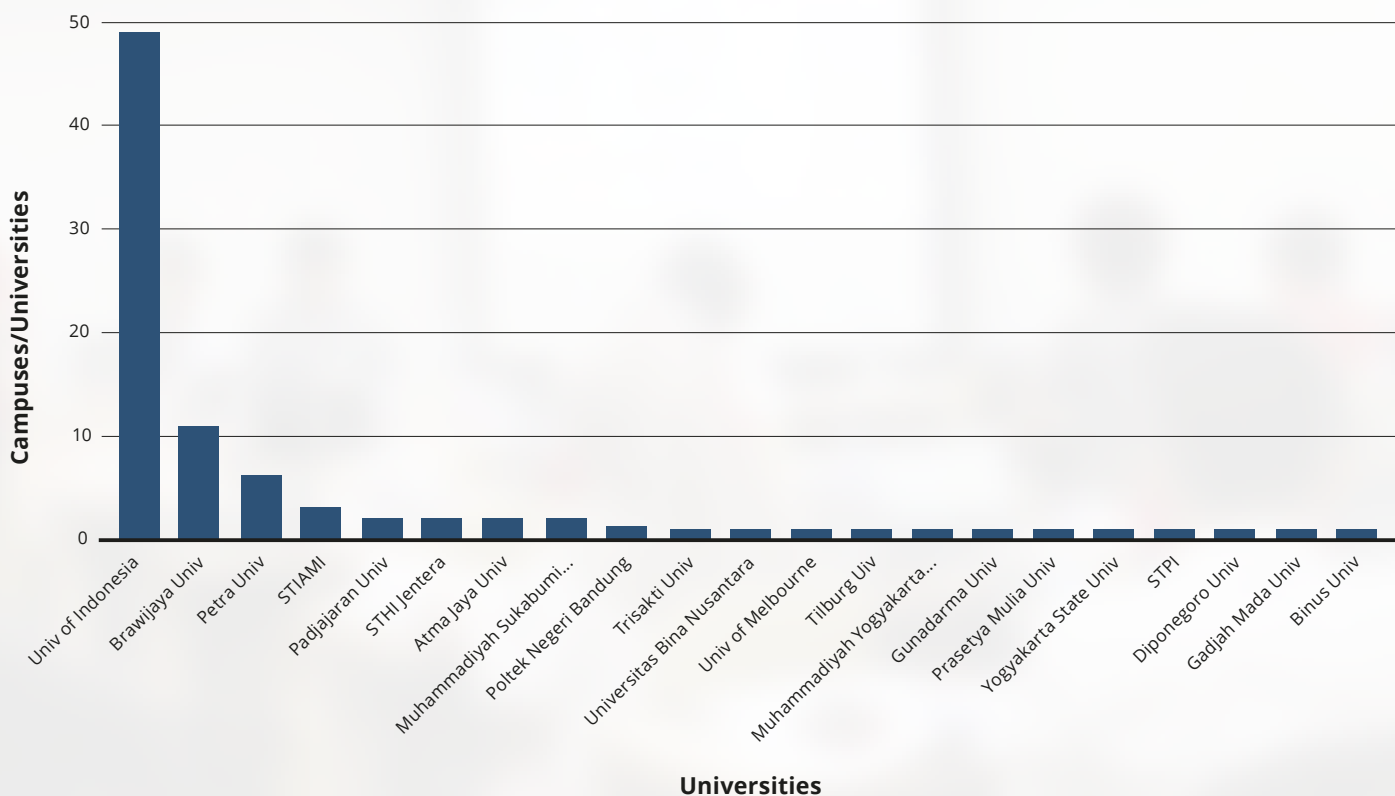
Gender
