2 years later, the management decided to rebrand the platform as DDTC Tax Engine.



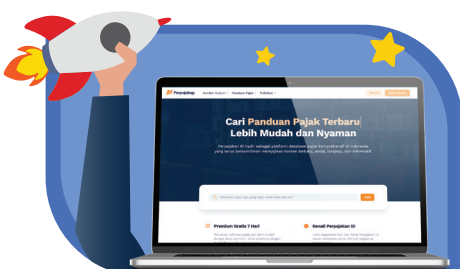
**2020**

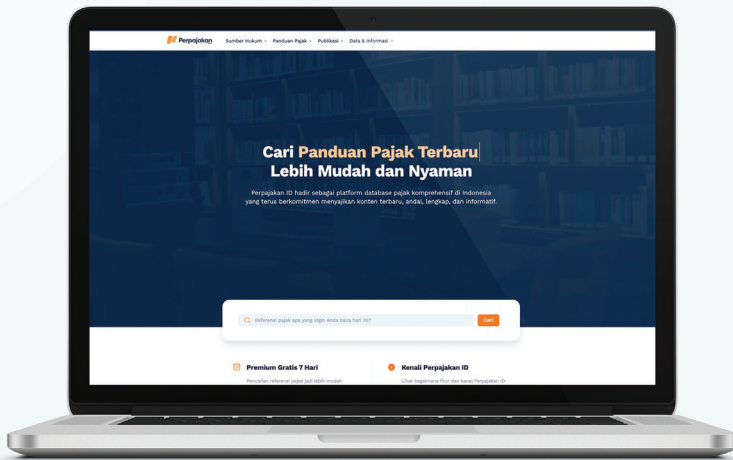
To keep up with technology advancement, DDTC formed a dedicated team called Digital Transformation which then fully managed Perpajakan ID.
