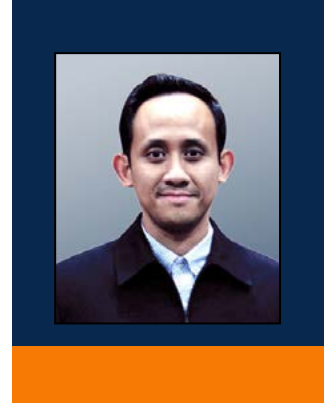


CURRICULUM VITAE – SENIOR RESEARCH ANALYST
