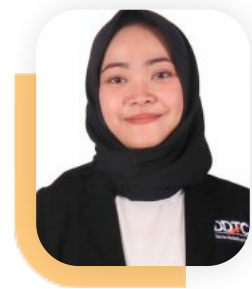


## RESYA FAMELIA ANIQOH
