



Tax Treaty Disputes in Indonesia

FREDDY KARYADI AND DARUSSALAM

1 Introduction

When tax treaty disputes in Indonesia are analysed using the black-letter, doctrinal approach, the exercise may appear to be rather fruitless. The system is relatively more opaque than in other G20 countries. Although most disputes are solved at the administrative level, no details of domes-tic as well as mutual agreement procedures are disclosed to the public. In relation to the few cases that are litigated, judgments are rarely publi-cised and those that are published usually contain no reasoning beyond statement of facts and conclusions. Although judges often apply a formalistic approach, judgments are ostensibly incoherent.

This chapter attempts to shed light on this otherwise unclear picture by

considering tax treaty disputes in Indonesia in their economic and insti-tutional context. The analysis takes as its starting point the fact that a rather extensive network of over sixty-five treaties has helped Indonesia to grow its economy at impressively high rates. This has allowed the formerly low-income country to establishing itself as a currently middle-income, prominent member of the G20. This enviable result was possible because Indonesia pursued a noticeably sophisticated and well-thought out policy.

In the early stages of the development of its treaty network, lasting from 1971 until 1990. Indonesia entered into a number of treaties with developed, capital exporting countries, including the Netherlands, France, Canada and Japan. Indonesia used the advantages of its economy, a large internal market and a high endowment of natural resources, 4 to negotiate
